

**Client/Student/Customer (Guest) Agreement for The Participation of Services
and/or Classes at Earth Harmony Eco Retreat Spa & Wellness**

To proceed with this agreement, you must be at least eighteen (18) years of age and legally capable of adhering to this agreement. This agreement is between Earth Harmony Eco Retreat Spa and Wellness, and its guests (clients, customers, students). Earth Harmony Eco Retreat Spa and Wellness has established the following required rules and regulations. Portions of our rules and regulations may also be stated on our website, verbally communicated, or printed on signs posted at our facility. You may contact management if you have any questions.

Responsibility

Anyone entering our facilities assumes full responsibility of their mental, medical and/or health condition, including any medications being taken which could result in a medical emergency or unsafe condition. All visitors must know their own limitations and assumes all risks associated with any activities in which they may engage in at Earth Harmony Eco Retreat Spa & Wellness. Earth Harmony Eco Retreat Spa & Wellness and its staff do not medically advise, diagnose, examine, prescribe, cure, or treat. Suggestions should not be construed as medical advice. Do not use our facilities if you are aware of any adverse conditions, including open cuts, abrasions, sores, infections, mental disorders, maladies, or an inability to maintain personal hygiene, and/or any condition that could threaten the health or safety of yourself and or others. You agree to use the facilities in accordance with all applicable public health requirements. The Spa reserves the right to deny entry to anyone for concerns of health or safety. Any violation of our policies, rules or regulations may result in the removal of the guest. No refunds will be issued if guests are asked to leave our facility.

During a stay, service or class at our facility, it is the responsibility of the guest to alert our staff immediately of any discomfort and request any modifications.

All guests waive their right to pursue any action, legal or otherwise against the Earth Harmony Eco Retreat Spa and Wellness, its owners, affiliates, and staff for any missing items, effects of our services, classes, or products.

Conduct

Guests must follow the instructions of our staff while visiting Earth Harmony Eco Retreat Spa & Wellness. Guests shall not conduct, purchase or subscribe to any commercial business or activity on our premises, or solicit other guests for any reason without the prior written consent from our management. Any complaints must be privately directed to the manager. Earth Harmony Eco Retreat Spa & Wellness reserves the right to eject from the premise any guest who fails to follow our policies, rules and regulations, or for any reasons of nuisance, disturbance, moral turpitude or fraud. Refunds will not be provided in these instances.

No Drugs or Alcohol

Smoking is strictly prohibited. Alcoholic beverages are strictly prohibited. If anyone is believed to be under the influence of alcohol or drugs, Earth Harmony Eco Retreat Spa & Wellness reserves the right, and the staff is authorized, to deny entry and or remove that person from the property. Appointment Policy

Please arrive 15 minutes prior to appointment time, clean, sober, wearing loose clean comfortable clothing, with no strong fragrances, when visiting our Retreat Center. To maintain the quality of our peaceful meditative environment, cell phones and electronics must be turned off prior to visiting our center. Video recording and photo taking is not allowed. Talking volume must be low and kept to a minimum, unless otherwise noted. Do not bring valuables. We are not responsible for lost or stolen property. Booking appointments will be confirmed by e-mail, text, or telephone. Current government picture ID (identification) is required upon arrival, and the name must match the name on the appointment booking request. For security purposes, 24-hour security alarms, video and audio recording is activated at all times. **Note: A minimum deposit of 50% of the fee is due immediately following appointment confirmation. Full payment must be made a week prior to arrival. Refunds will be provided only if the cancellation request is received no less than 48 hours prior to appointment time or cancelled by our center.**
